- I. Call to order
- II. Approval of Minutes: Change meeting location town to New Salem. Scott moved. Tanner 2nd. AIF

Event center was upset that some people had tied their horses to trailers in the camper area and they dug big holes. Next year there will be absolutely no horses in camping area. Tim was approached because the rough stock contestants took so long in the chute. Steve suggested that they maybe buck stock from one end to another (have a buck order but now necessarily form 12-1) and there was to many people on the chutes.
