## MINOR RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

I/WE HEREBY, RELEASE, WAIVE, COVENANT NOT TO SUE AND DISCHARGE the promoter, participants, rodeo association, sanctioning organization or subdivision thereof, arena operator, arena owner, officials, other participants, any persons in any restricted area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers and employees, all for the purpose herein referred to as "releases", from all liability to the undersigned, my/our personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or any demand on account of injury to the participant, including death, whether caused by the negligence of the releases or otherwise while the minor is in or upon the restricted area, and/or Competing, officiating in, observing, working for, or for any purpose participating in the event.

The Restricted Area is defined as the arena, chutes, staging areas, approaches thereto and all walkways, concessions and other areas appurtenant to any such area where any activity related to the event shall take place.
